

President's Column

writing this, my wife is busily preparing a meal for our first picnic of the summer. And my kids (ages 4 and 7) are busy asking me if I'm done writing this column yet as they know it has to be completed before we can go...

As usual, this newsletter is packed with articles. Of special note are the articles announcing the need

for candidates for our upcoming elections and for an Election Chair, the testing of a proposed electronic version and distribution of the newsletter, notification of upcoming bylaw changes, and more. I encourage you to take time to read every article in the newsletter!

As always, I encourage you to contact me with questions or comments concerning the ISWSC. It is through your comments, ideas, and suggestions that we continue to improve as a society.

During the past month, I was forwarded a letter from an ISWSC member asking about ISWSC dues and Swap Circuit fees. Since this is a question I often hear, I thought it best to address these issues in my column, rather than writing directly to the member.

The first question raised was concerning the contribution of 250 stamps for the youth program. The ISWSC application states members are "expected" to support the youth program through an annual donation of stamps or an equivalent financial contribution. Our website indicates members are "required" to do this. Nowhere, however, does it state what is the financial equivalent of 250 stamps!

This question raised two thoughts in my mind. First, one of the guiding principles of our society is the encouragement of stamp collecting (usually targeted at youth) around the world. It is through this portion of your annual dues that we help make this goal a reality. Second, as frustrating as it may

be, we purposefully don't dictate a financial equivalent of 250 stamps! Our hope would be that you give what you can to help spread the joy of stamp collecting around the world – whether that be a few stamps, some supplies, a dollar or two, or something significantly more.

The second question raised was concerning fees associated with the Swap Circuit. Although the main comment was concerning confusion over the fee structure, I'd like to reiterate to all members that Swap Circuit fees are separate from dues charged to

belong to the ISWSC.

ISWSC dues are charged annually to become (and remain!) a member of the ISWSC. These monies are used primarily to produce, print and mail The Circuit; cover administrative costs of operating the society; promote

the ISWSC; etc. Individuals must be a member of the ISWSC to participate in any of the ISWSC programs – sales circuits, the OMNI program, Swap Circuits, auctions, etc.

Swap Circuit fees, on the other hand, are annually charged only to those ISWSC members who choose to participate in the Swap Circuit program. (The word fee is deliberately used to help distinguish them from ISWSC dues.) These fees are used to cover all expenses of running the Swap Circuit program – no ISWSC dollars are used. Examples of Swap Circuit expenses include postage and supplies (glassines, envelopes, etc.) and the purchase of additional stamps to "sweeten" the circuit and replace damaged stamps.

Finally, the last question raised concerned finding the right place to send a question, submit ISWSC dues, etc. In each issue of *The Circuit* (except our

ISWSC Board Meeting

The following article is based on the ISWSC Board meeting minutes taken by ISWSC Secretary, Joanne Berkowitz (#98).

The ISWSC Board recently held its first e-mail meeting following the election of Ken Wills (#2150) and Rick Simpson (#1703). During the meeting, in which all Board members participated, the following items were discussed and/or action taken:

- The financial report for the first quarter of 2003 was reviewed.
- Membership statistics were reviewed, as were past recruitment techniques. The decline in membership appears to be over, with a slight increase in overall membership compared to one year ago.
- Tony Zollo (#856) was reappointed as Executive Director for 2003.
- Tom Fortunato (#379) was reappointed to the Executive Committee for 2003.
- Consensus was reached that the current bylaws are in need of revision and simplification.
 Randy Smith (#1111) will present proposed

- revisions to the bylaws to the Board at their meeting in July. Following discussion and revision by the Board, the final proposed bylaws changes will then be presented to the membership for a vote on their adoption.
- A suggestion was made to create a new class of membership based on electronic distribution of The Circuit. A sample PDF version of the newsletter was reviewed, as were costs associated with printing and mailing The Circuit. It was agreed that ISWSC members would be sought to help test this potential delivery option prior to its adoption. (Editor's note: See related article on page X).
- The following positions will be on the ballot in November: President, Secretary, Vice President of Public Relations, and Vice President of Charitable Programs.
- Scheduled Board meetings will be held each quarter, with other meetings held as needed. The next scheduled meeting of the Board will be in early July.



Nominees for Elected Office Sought

ne of the historical strengths of the ISWSC has been the number of members who have stepped forward to serve the society in various capacities. This strength must be relied upon again as nominees are now being sought for the following elected positions:

President

This person presides at all meetings of the ISWSC and its Board. He/she performs all duties incident to the office as described by Robert's Rules of Order and recommends such action as he/she believes will increase the effectiveness of the organization.

Secretary

This person keeps a permanent record of all society Board of Director proceedings, including Board meetings and votes. The Secretary also attests to all legal documents of the Society and performs other duties are requested by the Board and/or the Executive Director.

Vice-President for Public Relations

This person performs duties with respect to promoting the ISWSC, monitors and assists the ISWSC Regional Representatives, and is responsible for securing an Elections Chairman

Vice-President for Charitable Programs

This person serves as Chairperson of the Youth Program and assumes other responsibilities as assigned by the Board. This person also serves in place of the President, should the President be absent or unable to serve.

The term of office for each position is two years with a maximum of two consecutive years in the same office. Individuals in these positions, along with two at-large directors elected in opposite years, comprise the ISWSC Board and are responsible for the oversight and management of the ISWSC.

Any member of the ISWSC is eligible to run for elected office. To express your interest in running for a position, to obtain more information, or to recommend a fellow member for an office, please contact Randy Smith (#1111), ISWSC President, or Tom Fortunato (#379), ISWSC Vice President for Public Relations. Nominations must be received by September 15, 2003.

Whatzit?

ne of our members sent in three 1916-18 Austrian stamps (two regular postage and one newspaper stamp) with the "Rzp.Polska" overprint illustrated. These stamps are not in Scott or Michel but have been identified with the help of Hank Bieniecki of the Polonus Philatelic Society. They are listed in the Barefoot Catalog of "Poland 1918 Locals."



Poland local

Poland proclaimed independence in November 1918, at the end of World War I. Much of the country used locally overprinted German and Austrian stamps until the central Polish postal system was operational. While more local in usage, they are comparable to the regional issues listed as Scott #11-77.

Their use was terminated in January 1919. Rzp.Polska stands for "Rzeczpospolita Polska" (Polish Republic), which was also the name of the

(Polish Republic), which was also the name of the Polish Commonwealth (elective monarchy, with a strong nobility) which existed from 1572 until 1795, when the partitioning by Austria, Prussia and Russia was completed. The Austrian stamps bearing this

overprint were issued in Tarnow (in formerly Austrian Poland) on December 9, 1918. The overprints on the stamps are about the right size to be genuine, Bienicki noted, but it would take expertization to make sure.

The Latvian example is typical of stamps that crop up in mixtures. It is not in Scott. I found a Latvian-English internet dictionary and was able to learn that



Latvia unknown

"dzelzceli" means "railroad", and "laikrakst" means "newspaper". I could not find the other words. My guess is that these stamps were for newspapers carried by rail, but I would appreciate any reader's identification of these items.

How Did You Start Collecting Stamps?

o you remember how you got started collecting stamps? When or why? I believe two boyhood pals who lived around the corner got me started in most everything — raising pigeons, bantams, guinea pigs, etc. When they took up the coronet, I played the trumpet, briefly.

As a youngster, I always had a paper route, so when collection day came on Saturday, it was time to splurge a few pennies on chewing gum with an enclosed stamp, usually from Belgium, like Scott #68 which must be worth all of fifty cents now!

My uncle pumped gasoline (there were no electric pumps back then) at a local Shell station. The owners had a sale promotion involving sending collectors a stamped post card from their service stations around the world. While it was a thrill to receive the cards in the mail, I don't know whatever happened to them. Perhaps they were sold in my grandfather's bookstore where I sold a few stamp packets and actually did very well. My prices were probably too low!



My uncle in England learned about my hobby, so he mailed me the above cover with stamps of three British Kings: George V, Edward VIII and George VI. Is the "three kings" cover valuable today? Well, maybe, but at least I now have some proof I was a stamp collector back in 1937!

As I aged, my collecting experienced peaks and hollows. Somehow, in 1938, I began writing to a sailor aboard the *USS Mississippi*. Steve Salay always sent me the most beautiful covers, with photos of some ships. I don't know what happened to Steve, or his ship, because I became involved in a war of my own.

Stamp collecting took a back seat again in 1947 when I was married and infant television captured

much of our attention. But, my stamp album was always there, awaiting my return.



Learned About Stamp Clubs

I traveled around Ontario with Bell until retiring to Florida in 1979. For the first time, I discovered there were stamp clubs. I learned more attending meetings of the Tallahassee Stamp and Cover Club than I had picked up over the past 42 years. Good quality programs introduced me to the hobby and provided a source for adding to my collection while serving as an outlet for me to sell and trade duplicates.

I am asked frequently how much my collection is worth. I really don't know, but I learned at our stamp club meetings that I should be inventorying each of my albums to establish a value. That's my next project and I have started on it. Stamp clubs can also advise collectors about how their heirs can best dispose of their collections.

Where Do We Go From Here?

So, where do I — do we — go from here? Finding used stamps is a challenge with automation, so many self-adhesives being issued, and meter cancels. I once worked in a small office where I saw the mail clerk canceling letters in a meter machine. I suggested people usually consider envelopes with meter cancels as "Junk" mail, but people who see stamps on covers tend to open them because they seem more personal. Now she orders stamps from the Fulfillment Center and is on the mailing list for the United States philatelic magazine. But, addresses change and people move. So, guess who gets the the covers returned by the post office!

Stamp clubs can be a vital resource for you. I urge members to become involved, to run for office, volunteer to present a program, encourage youth (which I once was, believe it or not) to take up stamp collecting. There's no greater hobby in the world.



The Luxury of Travel (Islands of the South Atlantic)

ecently, I had a convergence of thoughts. While driving along, enjoying the freedom of movement and travel, I was thinking about the purchase of stamps I recently made for 25% of catalogue value.

My mind began to wander and my creative thoughts began to flow. You know, we are lucky. If you or I want to travel to another state or city or town we simply hop in our cars and away we go. This is truly a wonderful luxury that does not occur in many parts of the world. One of those places where this luxury of travel does not occur as regularly as here in New York State, is Tristan da Cunha.

Tristan da Cunha is a remote, almost circular island in the middle of the South Atlantic Ocean discovered by the Portuguese explorer Tristao da Cunha in 1506. Tristan was formally annexed by the British during August of 1816. It has a whopping population of about 300 souls. This island is the largest island in the Tristan group, composed of a series of smaller uninhabited islands, named Nightingale, Inaccessible, Middle and Stolenhoff, respectively.

So what about the freedom of movement on Tristan? Well, the Royal Mail Ship St. Helena calls at Tristan only once per year, on its January/February voyage. Of course, that's the summer season for them. According to reports, the RMS St. Helena only stays for two to three days per year, during which


Sales Circuit Update



Collecting One Stamp Per Country

Since collecting one stamp per

country is an ever-expanding

collection, my research will

never truly be done.

hen I started collecting stamps as a young boy, I was always fascinated with the stamps of the many mysterious countries around the world. Even though I specialized in collecting United States and United Nations stamps, I always kept the worldwide stamps I received from family and friends.

Eventually when I was about eighteen, I invested in the *Minkus Supreme Global Stamp Album* to store

these stamps. However, the vast number of new stamps being issued every year combined with family and work responsibilities resulted in having an accumulation of worldwide stamps and not a collection.

After over forty years of collecting worldwide stamps, I found that I had over one thousand stamps from countries like Hungary and the Soviet Union and not a single stamp from Kuwait, Norfolk Island, or Zambia. So about four years ago, I decided to start a collection of one stamp per country.

Armed with just my old Minkus Supreme Global Stamp Album and Compton's Encyclopedia on CD-Rom, I developed a list for my one stamp per country collection. My list includes not only current countries of the world but countries that no longer exist ("dead countries"), post offices abroad, military occupations, etc.

For a single country like Angola I would have two entries, one for Angola as a Portuguese colony and another as an independent republic. In the case when a country issued stamps, stopped issuing stamps, and resumed issuing stamps, I would have two entries for that country. As an example, I would have one entry for the Lithuania for the period 1918 to 1940 and another for after 1992.

For each stamp issuing entity I collect one mint stamp and one used stamp. I prefer that the stamp depict something about the country from which it came. For instance the stamp for Argentina in my collection has Eva Peron on it and the one from Spain has General Franco. I also made a separate section for Locals and Bogus country issues. This section is for entities like Carpathian Ukraine, a small part of Czechoslovakia that in March 1939 was an independent country for about three days and issued only one stamp, to an entity like Abkhazia, a province of Soviet Georgia that since 1994 has issued hundreds of stamps whose postal validity is very questionable.

My one stamp per country collection has about

eleven hundred entries and is displayed in three Lighthouse Vario albums.

About eight months ago I decided to expand my list by drilling down a level. I decided to add an entry for every time in a country's history that it had a major change in its form of government. As an example, for the Caribbean island of Dominica I originally had two entries, one for when it was a British colony and another for when it became independent. Upon delving further into Dominica's philatelic and political history, I learned that Dominica issued

stamps as a British colony from 1874 to 1890. It then came under the administration of the Leeward Islands and stopped issuing its own stamps. In 1903 Dominica

as a British colony started issuing its own stamps again. In 1967 Dominica in preparing for independence became an associated state of Britain. Since 1978 Dominica has become an independent country. I now have four entries for Dominica.

In order to be able to research a countries history at this level, I have invested in the *Scott Stamp Atlas*, the *Stamp Atlas* by Stuart Rossiter, *Linn's World Stamp Almanac*, and *Scott's Classic Specialized Catalogue*. Also, articles in *The Circuit* and other philatelic publications help. I use multiple reference books because one source will list the small Caribbean island of Redonda and another will not.

I was amazed how many facts in these books contradict each other when researching those small areas of the world like the many different stamp issuing entities during the Russian Civil War. When this occurs, I choose the fact that seems the most reliable. I can say that all these reference books will agree that the United States became independent on July 4, 1776 and Britain issued the first postal stamp in 1840.

At my present rate of progress, I have at least seven more months of research on my expanded list. Since I enjoy collecting stamps and studying history, my research has been a fun experience. However since collecting one stamp per country is an ever-expanding collection, my research will never truly be done.

Did you know that Yugoslavia formally changed its name Serbia and Montenegro on March 14, 2002 and East Timor became an independent country on May 20, 2002?

passengers get ashore only if the weather is obliging.

But this is not the end of my story because you see, Tristan da Cunha is a dependency of St. Helena. St. Helena was also first claimed by a Portuguese navigator. He was Juan da Nova Castella, sighting land on May 21, 1502. The island was named for Saint Helena, the mother of Constantine the Great. After its discovery, this island was used by the Portuguese as a fresh water stop for their fleets returning from the East Indies.

During this time, its location was a closely kept Portuguese secret, until 1588 when that the English navigator Thomas Cavendish located the island. The secret was out! From that year forward the island was intermittently used by the Portuguese, English and Dutch.

In 1633, the Dutch formally annexed the island but did not occupy it. Occupation of the island had to wait until May, 1659 when the English East India Company claimed the island under a charter from Charles II. The first inhabitants of the island were company employees, English settlers and slaves from South Asia, the East Indies and Madagascar.

Still unable to place St. Helena? Well it is actually quite famous! You see, Napoleon was exiled to this land in 1815. With this famous dignitary came a large garrison of British soldiers and naval ships on constant patrol in case of a rescue attempt. When Napoleon died in 1821, almost all of the garrison was withdrawn. But St. Helena has been visited by many other dignitaries, like Charles Darwin in 1836 on the homebound leg of his voyage on the Beagle. Dinizulu, the son of Cetwayo of Zulu War fame, and his entourage were confined on the island, as were 6,000 Boer prisoners of war during the Boer War.

With its up and downs, St. Helena survives with a current population of 5,800 individuals. The island economy has become almost totally dependent upon a single commodity — New Zealand flax — used as ropes and string. St. Helena is also serviced by the *RMS St. Helena*.

While this has all been interesting — to me at least — it is still not where I want to be. Rather my destination is another dependency of St. Helena located almost exactly in the middle of the South Atlantic, namely Ascension Island. Like St Helena, Ascension was first spotted in 1501 by Juan da Nova Castella, but the finding went unrecognized. The official discovery of this island had to wait for Alfonso d'Albuquerque, who in 1503 rediscovered

What is really important is for all Swap Circuit members to adopt a version of the "golden rule." Put into the circuits the kinds of stamps you would like to find in them.

This means put in interesting, useful stamps, stamps from unusual countries, new issues, higher values. Even though the stamps are large there is no sense in putting in the Nigerian definitives of 1973, Netherlands investiture of Queen Juliana (#304), Canada's 1937 coronation issue, etc. The same applies to the Christmas issues of larger countries. These are the stamps to donate to groups that give stamps to kids, or to put in that old box in the attic.

If you have seen a stamp in the Swap Circuits or dealers' nickel-boxes many times, there is no point in wasting everyone's time and postage money by putting it into the Swap. No one has a use for it.

The Swap Circuits are not a way to get rid of unwanted stamps, they are a way for serious collectors to exchange useful stamps to put into their albums!

the island on Ascension Day. Currently, this island has a population of about 1,350 individuals, of which 850 are St. Helenians, 100 Americans and 350 are

British (165 of which are members of the Royal Air Force). Both the US and British Air Forces maintain a presence on this island.

So what does this have to do with stamps? Well, it was a wonderful deal on Ascension Island stamps at 25% of catalogue value that sent me on this trek. After all, you can't

own Ascension Island stamps and not know where it is located — can ya??!! Well, look for it in the middle of the South Atlantic Ocean, almost exactly between South America and Africa, far off the coasts of Brazil and Angola, respectively.

Now that we have arrived at Ascension Island, what about its philatelic history? Well, the stamps of Great Britain stamps in values ranging from ½d to 1s were used on Ascension Island prior to 1922. In that year, Ascension Island became a dependency of

St Helena, and stamps of St. Helena overprinted "Ascension Island" were used for postage.

Since the end of World War II, Ascension Island has participated in all the colonial omnibus issues. All told, my catalogue tells me that through 1994 this island has issued a total of 574 commemorative and regular issue stamps, plus 6 postage due stamps.

There is only one post office on the island, located in the town of Georgetown. Flora, fauna, and historical events are common themes on these very collectable British Commonwealth stamps.

Oh — and guess what? You can visit Ascension Island via the *R.M.S. St. Helena* which makes its rounds annually. So much for the luxury of travel!
